## **RULES AND REGULATIONS FOR MEMORIAL ROSE GARDEN ECCHINSWELL ROAD CEMETERY, KINGSCLERE.**

The following RULES AND REGULATIONS are made by the PARISH COUNCIL OF KINGSCLERE, HAMPSHIRE, in accordance with the General Power of Management granted to the Council in their capacity as a BURIAL AUTHORITY by Article 3(1) of the LOCAL AUTHORITIES CEMETERIES ORDER 1977 promulgated as Statutory Instrument 1977 No.204.

These Regulations shall refer to THE ECCHINSWELL ROAD CEMETERY, KINGSCLERE.

'the Council' refers to Kingsclere Parish Council: 'the Clerk' refers to the Kingsclere Parish Clerk, proper legal officer of the Council.

### **ROSE MEMORIALS**

- (a) Only roses of a shrub or bush variety may be planted. Climbing or Rambling roses, Hybrid Tea or Standard Roses will not be permitted.
- (b) All memorial Shrub Roses and Memorial Plaques and inscriptions thereon are subject to the approval of the Council and a copy of every inscription proposed and a drawing showing the design and dimensions of every memorial proposed to be erected, must be submitted for approval to the Clerk with the application on the prescribed form.
- (c) Only memorials which comply with the following regulations will be approved:-
  - (i) No rose plot shall exceed 45cms (18 inches) square.
  - (ii) The memorial plaque should not exceed 15 x 7.5cms (6 x 3 ins) and be on a peg that stands in the ground being no higher than 15cms (6ins)
  - (iv) The plaque should be of Teak or Oak and can be mounted with a brass plated inscription.
  - (v) If any damage is caused to other roses in planting your rose, the person or persons causing the damage will be required to make it good.

### **MAINTENANCE OF MEMORIAL ROSES**

It is the responsibility of the owner to regularly maintain his or her rose and plaque. The Parish Council reserves the right to remove any roses that are left neglected and cause intrusion into other memorials.

### **REGISTER OF MEMORIAL ROSES**

A Register of Rose Memorials will be kept and searches may be made and extracts obtained without charge on application to the Clerk during normal office hours.

### **CEMETERY OPEN TO THE PUBLIC**

The Parish Council reserves the right to close the Cemetery to the public at any time before and while a burial is taking place.

Children will not be admitted except under the care of a responsible person.

Dogs are not permitted in the Cemetery (with the exception of Assistance Dogs).

All visitors must keep to the roads and walks, refrain from touching shrubs and flowers, and observe perfect decorum in all respects.

### **COMPLAINTS PROCEDURE**
